Payment of Medical bills of Retired Employees - Reg.

This has reference to this office letter of even no dated 30.08.2002 and subsequent emails regarding payment of medical bills of retired employees. It is intimated that:

- 1. The CBB section of Corporate Office had allotted Rs. 316 Crores to the Circles in the last week of August 2022 for clearing all the medical bills of retired bills parked/posted in ERP-SAP upto 31.03.2022. It has been noticed that as on date Rs. 33 Crores are still lying unutilized with the Circles. CBB section vide letter No. 16-4/2019/RB/Fund Auth/MISC/PI-I(P) dated 07.10.2022 had also written to Circles regarding clearance of pending liability of Medical bills of retired employees in ERP-SAP. The Circles were further requested through emails also to clear all the medical liability of retired employees.
- 2. This Office vide above Letter have also directed Circles to post the medical bills of retired employees on regular basis so that funds for discharging the same can be given along with salary disbursements. Despite categorical instructions there are several complaints from retired employees as well unions/associations that either Circles are discriminating in making payments or the payment is not being made despite availability of funds.
- 3. The reasons quoted by some of the Circles for delayed payments were (i) the retired employee vendors not created, (ii) Bank particulars were not updated, etc. It is pertinent to mention that the vendor creation is a mandatory activity for paying medical bills in case of retired employees and the Circles ought to have taken all steps in ERP-SAP timely.
- 4. On perusal of data of retired employees' invoices in ERP-SAP, it has been observed that several invoices are still lying as unpaid in system (Annexure I) whereas funds were given as per the data furnished by the Circle itself. The Circles are required to furnish the following information in respect of retired employees
