Dear comrades,

The meeting of the AUAB was held at New Delhi on 27-04-2022. Discussions in this meeting were inconclusive. Hence, the meeting was adjourned and again it was held online on 04.05.2022. For taking final decisions, one more meeting was held online on 11.05.2022. General Secretaries / Representatives of BSNLEU, NFTE, AIGETOA, SNEA, SEWA BSNL, AIBSNLEA, FNTO, SNATTA, BSNL MS, TEPU, BSNL ATM, AITEEA and BSNL OA, participated in these meetings. Com. Chandeshwar Singh, Chairman, AUAB, presided over all the meetings.

Serious discussions were held on the burning problems of the Executives and Non-Executives of BSNL. Especially, the most important issue of non-settlement of 3<sup>rd</sup> Pay Revision for the Executives and 3<sup>rd</sup> Wage Revision for the Non-Executives, was discussed prominently. Similarly, the non-settlement of the issue of E-2 / E-3 pay scales, non-settlement of the issue of Superannuation Benefits, insufficient vacancies in JTO LICE, filling up of the SC/ST backlog vacancies and non-fulfilment of the assurances given by the CMD BSNL, in the meeting held with the AUAB on 27.10.2021, were viewed seriously.

After in-depth discussions, the AUAB unanimously decided to organise serious agitational programmes, demanding the settlement of 3<sup>rd</sup> Pay Revision / 3<sup>rd</sup> Wage Revision issue. Similarly, it has also been decided to organise agitational programmes on non-settlement of the issue of E-2 / E-3 pay scales, non-settlement of the issue of Superannuation Benefits, insufficient vacancies in JTO LICE, filling up of the SC/ST backlog vacancies and non-fulfilment of the assurances given by the CMD BSNL, in the meeting held with the AUAB on 27.10.2021. The agitational programmes are as follows:-

- (1) Lunch hour demonstrations on 3<sup>rd</sup> PRC / 3<sup>rd</sup> Wage Revision shall be organised on 27.05.2022.
- (2) Dharna on E-2 / E-3 pay scales issue, SAB, JTO LICE, filling up of SC/ST backlog vacancies, non-fulfilment of the assurances given by the CMD BSNL, shall be organised on 09.06.2022.
- (3) Twitter campaign on 3<sup>rd</sup> PRC / 3<sup>rd</sup> Wage Revision shall be organised on 14.06.2022.
- (4) Submitting of memorandum to MPs and Ministers on 3<sup>rd</sup> PRC / 3<sup>rd</sup> Wage Revision shall be organised from 01.06.2022 to 30.06.2022.
- (5) Date of March to Sanchar Bhawan will be finalised in the next meeting of the AUAB.
- (6) The accounts of the 3 day dharna conducted at Jantar Mantar on 21<sup>st</sup>, 22<sup>nd</sup> & 23<sup>rd</sup> September, 2021, is already approved by the earlier AUAB meeting. However, there is a shortfall and the following contributions were announced in the meeting, to compensate the shortfall.

AITEEA - Rs.5,000/-SEWA BSNL - Rs.3,000/-BSNL MS - Rs.3,000/-

All the constituents of the AUAB are requested to take all out efforts, to successfully implement the aforementioned decisions.
