With regard to all other cases, pending issues may be settled on top priority so that the complete cases are sent to respective CCAs for generation of PPO within this month.
- 3. In this regard, it is requested that personal attention may be given to each case so that this exercise is completed within this month itself so that we may request DOT to give full amount of Ex Gratia.
