**Review of results of failed SC/  
ST candidates in LICE - revised  
guidelines regarding.**

*Letter No. 9-2/2016-Rectt. Dated 28.08.2017 to  
All Heads of the Telecom Circles\* BSNL (\*Re-  
cruiting Circles only)*

The undersigned is directed to intimate, that instructions issued vide letter no. 250-22/2013-Estt-III dated 28.07.2016 on the subject above is hereby superseded as decided in the 35th meeting of National Council held on 11th May 2017. In the said meeting it has been agreed to review the result of failed SC/ST candidates in the light of DOT letter dated 22-5/91-NCG dated 30.11.1992 which stated that "Result of only those failed Scheduled caste candidates who have secured at least 20% marks and Schedule Tribes candidates who have secured at least 15% marks in each paper should be reviewed".

As such the applicable date for this review of results will be same as mentioned in letter no. 250-22/2013-Estt-III dated 28.07.2016.

This has got approval of competent authority.
