Subject: Immediate settlement of pending issues in respect of retired employees under BSNL VRS-2019.

Sir.

I am directed to refer to the DO letter No. BSNLCO-EB-I/11(20)/5/2020-ESTAB dated 28.07.2020 issued by DIR(HR) and to request you to carry out the following actions on priority:

- In respect of the cases wherein copies of PO are not traceable / not issued, such cases may be settled immediately in coordination with respective CCAs.
- (ii) In respect of the cases wherein the retirees have not submitted their pension papers on SAMPANN portal, reminders may be issued through registered post as well as through phone calls and SMS. Every week one reminder may be issued for next four weeks or till they fill their pension form. Such VRS optees may also be informed that BSNL will not be responsible for the delay in finalization of pension and other benefits.
- (iii) With regard to the cases pending for Caste certificates, letters may be issued to the retirees for submission of Caste Certificate clearly stating that payment of Ex-gratia will not be settled in their case till the completion of the stipulated formalities.
- (iv) In respect of any pending recoveries in respect of VRS-2019 retirees, the recovery amounts are to be adjusted from the 4th installment of the Ex-Gratia. The concerned officers / official will be held personally responsible for any such lapse in recovery.
- (v) In respect of the cases where last pay drawn or qualifying service has been corrected / reduced by the CCA and accordingly, PPOs have been generated, such cases may be updated in the ERP / SAP with regard to the amount of Ex-gratia, encashment of EL / HPL payable to the retirees of VRS-2019. The recoveries, if any, with regard to the pay & allowances drawn in excess may be recovered by following the due process.
- In this regard, it is requested that the above activities may be completed on top priority latest by 14th August 2020 so that pension cases of all VRS-2019 retirees gets settled without any further delay.
