Subject:- Formation of "Bharat Sanchar Nigam Limited" W.E.F. 1-10-2000.

With the formation of "Bharat Sanchar Nigam Limited": from 1-10-2000 it is expected that the newly formed Corporation will start their accounts separately for the transactions from 1-10-2000. Necessary instructions are being isued to the RBI, Central Office, Mumbai to advise the RBI, CAS, Nagpur and other Banks in Operation with DOT/DTS not to entertain the new transactions to be taken place w.e.f.1-10-2000 relating to drawing from and remittance to Bank in the old Bank accounts and in the RBI, CAS, Nagpur accounts Code allotted to each circle Accountant. After completion of the reconcilation of balances with RBI, CAS, Nagpur, the Department of Telecom (HQ) will issue a formal letter to the RBI, Central Office, Mumbai with a copy to all concerned requesting closure of all drawing and remittance accounts to enable RBI, CAS, Nagpur to close the Circle

- The RBI, Central Office, Department of Govt. and Bank accounts, Mumbai may also desire a list indicating names and designation of the Circle Accountant, name of the Focal Point Branch, name of Drawing officers, name of the Bank dealing branches of the Concerned Bank of RBI, SBI and nationalised Banks etc/ presently with whom the Bank Accounts were opened and operated by different D.D.Os against circle Accounts Code allotted by the RBI, CAS, Nagpur. The list may be prepared and sent to the Chief General Manager, RBI Central Office, Deptt. of Govt. and Bank Accounts. Mumbai with a copy to this office.
- The RBI, Central Office, Mumbai may also desire that while tendering the Cash and Cheques (collected and acounted for in the Cash Book till 30-09-2000) alongwith remittance challans to the concerned Bank's branches for clearance and credit to the accounts of DOT, the remittance challan may indicate the date 30-09-2000 / the actual date of presentation of the Cash / Cheque(s) to the Bank for clearance. The banks will accept all such cash or cheque (s) upto the first week of 10/2000, but afford credit to DOT/ after clearance of the cheques, against concerned Circle Accounts Code.
- All the Drawing Officers who are drawing funds against your concerned Cirle Accounts Code may be directed to intimate last cheque drawn by them upto 30-09-2000 to the dealing branch of the Bank with whom Bank transactions being made with a copy to CAO (TA) / AO (TA) of your office. They should cancel all the unused cheques foils of current cheque Books in use on 30-9-2000 or last working day of september, 2000, over the signature of Drawing Officer intimate particulars of cheque foils so cancelled to the (TA) / AO (TA) of your office. Unused cheque books may please be withdrawn from all the Drawing officers and sent to the CAO (TA) / AO (TA) of your office duly preparing a list of unused blank cheque books. After proper verification of these unused Cheque Books, these will be handed over to the Oficer-in-charge of the "DOT-Cell" Unit to be created for residual transactions of DOT at each circle headquarter, for further disposal. All the drawing officers may be directed not to use/ operate the Cheque Books of DOT w.e.f. 1-10-2000.
- In addition, all the instructions relating to closing of accounts on 30-09-2000 as conveyed through our office letter No.41-1/2001-TA-II dated 14-09-2000 should be scrupulously observed.
