

Sub: Holding of online LICE for JE under 50%<sup>^</sup> quota for the RY-2017 for vacancies up to 31.03.2018---regarding.

Kind attention is invited to your office letter No. 7-11/2018-Rectt. dated 04.10.2018 on the above mentioned subject. In this regard it is intimated that following discrepancies have been found in the said order, which needs immediate amendment.

(i) There is no reservation of OBCs in the promotion quota. As such, OBC category should be removed from the said notification.

(ii) As per existing instructions of DoP&T, 3% reservation has to be given to PWDs in promotion quota i.e, in 50% LICE for JE. Point Nos. 1, 33, & 67 of the roster are earmarked for the respective categories of PWDs in the two categories viz. 1.5% each in OH category and 1.5% in HH category. Accordingly, you are requested to revise the aforesaid notification dated 04.10.2018 for calculation of vacancies at the earliest.
