**Sub: Relieving of officers/officials in the cadre of JE(T)/ JTO(T) who have overstayed beyond the permissible period of temporary transfer under Rule-9 - regarding.**

In reference to the subject cited above, the data concerning Rule-9 transfers 'from the Circle' and 'to the Circle' was collected vide this office letter no. BSNLCO-A/16(11)/4/2023-ESTAB dated 02.11.2023 from all the territorial circles.

2. In the light of the terms and conditions conveyed vide Rule-9 transfer policy dated 27.08.2021, it has been observed that there are some officials/ officers in respect of JTO (T) and JE (T) cadres (**lists enclosed as Annexure I & II**) who have completed the approved period and are overstaying beyond the approved/permissible period under rule 9 transfer.


3. In this regard, this office has already issued **letter no. BSNLCO-A/15(22)/28/2021-ESTAB dated 21.02.2023** vide which all the Circles were asked to check the period of Rule-9 transfer of officers/officials working in their circle and relieve the officer/ official on completion of approved temporary transfer period immediately adhering to Rule 9 guidelines strictly. However, some of the circles are not adhering to the provision of Rule-9 Transfer and further guidelines issued in this matter from the Corporate office.

4. In view of above, the heads of circles are requested to relieve such officials/ executives in cadres of JE (T) and JTO (T) as mentioned in enclosed Annexure I & II before 31.03.2024. If there are any other official/ officer whose name is not listed in the above Annexures but has completed the approved period of Rule 9 temporary transfer, he/ she may also be relieved before 31.03.2024.

5. It is further emphasized that henceforth, any overstay beyond the approved period of temporary transfer under Rule- 9 Policy shall be treated as irregular and the concerned official as well as the senior officers of the circle will be held responsible.

This issues with the approval of the competent authority.
