**Subject: Submission of representation as part of Agitational Programme protesting undue delay by DoT in endorsing DPE OM dated 27.02.2026 for implementation of IDA revision w.e.f. 01/01/2026 for Executive and Non-Executive employees working in BSNL.**

**Respected Sir/Madam,**

We the executives and employees of BSNL want to draw kind attention towards undue delay of four months in conveying approval by Dept of Telecom for releasing IDA payment of BSNL Executives and employees.

IDA payment is routine matter and as per prevailing guidelines it cannot be kept on hold for any reason including any emergency and the same has been confirmed by Honourable Supreme Court.

We the members and leaders of all Unions and Associations of BSNL have registered our protest by holding Lunch Hour demonstrations on 20/04/2026, wearing black badges on 23/03/2026 and today we are submitting this representations to all CCAs all over India including your honour.

Please accept our representation with request to convey/forward anguish/unrest, feelings and extreme displeasure among BSNL executives and employees to the office of Secretary Telecom for king intervention respectively for implementation of the IDA enhanced w.e.f. 01/01/2026 with arreaers from Jan to March 2026. is released in the salary/Pension of April 2026.

Further it is further requested to convey the mass unrest and explosive situation among BSNL Executives and Employees to Secretary DPE as DPE has put this condition without any justified reason which has delayed enhanced IDA implementation. Now IDA for April 2026 is due but this stringent condition under para 5 put by DPE is the main reason for release of IDA.

Otherwise, we will be compelled to go ahead with the following next agitational programme which is as follows.

1. **27.04.2026:** Twitter Campaign.
2. **30.04.2026:** Extending support with active participation in the countrywide dharna programme by the pensioners associations and organize a "protest

chain” at all BSNL offices and exchanges to highlight strong resentment on the issue and Sanchar Bhavan.

**3. 07.05.2026: March to Sanchar Bhavan.**

We convey thanks for understanding our hardship and difficulties and for giving us time. We further request to recommend/forward this representation to Secretary DoT, Secretary DPE so as to payment of enhanced IDA in salary/Pension of April 2026 and for early release of OM for enhancement IDA due w.e.f. 01/04/2026.

We earnestly hope that the necessary orders will be issued by DoT and we will not be compelled to protest against inaction of DoT officers on this simple issue.
