4. However, Paper-II is descriptive/conventional in nature and will be conducted in written (pen and paper-based) offline mode. The proposed tentative date for conducting Paper-II is 22.05.2026 (Friday) (Tentative). The examination centre for Paper-II will be in Delhi (NCR). The exact venue and timing of the examination will be communicated in due course.
