1. As you are aware that the CGMT has held discussions with you all, the representatives of the Circle unions/associations, on several occasions and duly considered your suggestions.
2. Based on your feasible suggestions received, the restructuring proposal has been suitably revised and forwarded to BSNL Corporate Office, where it is presently under active consideration. In these circumstances, resorting to agitation at this stage appears premature and avoidable.
3. It may be noted that the initial/original restructuring proposal was received from BSNL CO on 04.07.2026 and UKD circle has submitted various suggestions and queries to BSNL CO for consideration and issuing the required clarification w.r.t the implementation of the restructuring proposal.
4. As the suggested restructuring proposal submitted by the circle is under process of final approval at BSNL CO, the proposal shall be implemented in due course after final instructions/approval from BSNL CO.
5. All efforts will be made to ensure that most of the genuine concerns/issues of the employees will be considered before implementing the modified proposal through consultative process with the unions/associations.
6. Accordingly, in the larger interest of BSNL, its employees and its valued customers, you are requested to withdraw all agitational programmes with immediate effect.

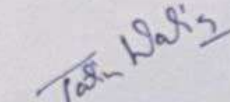

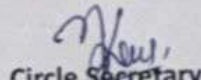

In view of the positive discussions held and the assurances conveyed by your good office through the letter under reference, as well as the ongoing programme of the AUAB CHQ,

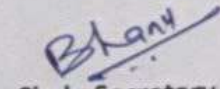
